Our fight for higher standards and financial accountability begins with all union members educating themselves about the charters in East Cleveland and in our own communities. We need to coordinate our efforts to educate our community on failing charters and the resultant draining of resources from our public school system—East Cleveland. Knowyourcharter.com is a useful tool to educate your family and friends, spark conversations and fight for greater accountability of Ohio's charter school operators and authorizers.

It is our responsibility to help others make educated decisions when it comes to finding the best schools for our children. It is also in our best interests to show how charters with failing grades take money from our traditional community schools and funnel these dollars, in many instances, to for-profit-businesses. The money that charters drain from East Cleveland or your own school system in which you live is a threat to OUR job-security and further reduces educational resources for our EC children and your own children. Our community and your own community need good schools and jobs; most charters are a drain on good jobs and good education.

ECEA Member Honored as Unsung Hero

Karen Winston, a Chambers teacher, was awarded the Unsung Hero Award at the United Labor Agency's (ULA) annual meeting in November at Landerhaven. NEOEA is a member of the ULA and seeks nominees each year. We also have two past recipients in East Cleveland—Steven Mitchell and Dawn Magnasco.

We thought you would enjoy reading Karen's speech ... As I contemplated what to say this evening, I couldn't help but to think about my union roots. You see, I am a fifth generation union member. Most of my family members belong to UAW or are Teamsters. My dad is a retired UAW member; GM Parma Plant. I grew up in the Fisher-Body Plant neighborhood of Collinwood in the city of Cleveland. So the common thread on my street was being in an union family. The thought of being a fair-share member never crossed my mind, unless I planned to find a new family to spend my holidays and the rest of my life with!

With that being said, I was eager to submit my paperwork to join the East Cleveland Education Association. Conversely, to my surprise, that same enthusiasm would serve a greater purpose... You see, my first year as an educator was also a strike year. I shared this news of a strike with my dad and his natural response was "well I do DECLARE!"As if it was time to go to war. "We must get ready! I will get the barrel, fire wood, cooler, and a few bricks!

So I am on the other end of the phone thinking "How can I tell him he can't come to our picket line? I don't even want to know what the bricks are for? I am afraid we may be arrested!" I took that same energy from the picket line and redirected it into efforts that would build the capacity of my union and set an example for my students and my son by placing my time, talents, and even finances in what I believe in.
