Yes, We Do still have a contract!

I'm sure you have heard the whispers and in some cases, the shouts. Fellow teacher union members cry, "We have no contract!" Administrators may say, "Your contract is now null and void." This is simply not the case. Our contract was extended on August 18, 2018 and is set to expire on August 17, 2020. We met as a general body and voted to extend our collective bargaining agreement. Upon the advice of legal counsel from OEA, ECEA opted to extend the contract until August 2019. Some may wonder why we did not extend it past August 2019. The reason for this is two-fold. First, it allowed us to have a valid contract in place before the appointment of our new CEO. However, it also gives the ECEA and our CEO, Dr. Pettiegrew, the opportunity to collectively agree on a new contract. A CEO is far less likely to suspend or void out a contract that he had a hand in creating. Initial conversations with Dr. Pettiegrew seem promising. He has already spoken of his desire to reopen collective bargaining negotiations for the upcoming school year. So let's go bravely but carefully forward. And remember, the CEO may not reduce any base hourly rate of pay and may not reduce any insurance benefits.

The chart below gives a non-exhaustive summary of the CEO's powers taken from the OEA's Analysis of HB 70. You can read OEA's HB 70 analysis at https://tinyurl.com/yxmwa8zn. This analysis was shared earlier in the school year on September 23, 2018 via email by your ECEA officers. If you have additional questions, please have conversations with your ECEA officers and building reps. Please be sure to attend building meetings to stay informed and discuss any concerns. If we don't have an answer to your question, we will work hard to find someone who does. And lastly, remember UNITED WE BARGAIN, DIVIDED WE BEG!

Powers of the CEO

End of Year 1

The CEO may reopen collective bargaining agreements, may reconstitute any school operated by: changing the mission of the school; replacing administrators; and replacing a majority of the teaching and nonteaching staff.

End of Year 2

The CEO retains all powers bestowed in the previous year(s) and now has the power to limit, suspend, or alter any provision of a collective bargaining agreement entered into, modified, renewed, or extended on or after the bill's effective date to reconstitute a school.

End of Year 3

The CEO retains all powers bestowed in the previous year(s) and the CEO may continue in effect a limitation, suspension, or alteration of a provision of collective bargaining agreement.

End of Year 4

The CEO retains all powers bestowed in the previous year(s)

End of Year 5

The CEO retains complete operational, managerial, and instructional control of the district until the CEO relinquishes that control once a district transitions out of being subject to an academic distress commission.
